

## **KEY FINDINGS**

- Voters are overwhelmingly supportive of national parks 66% have visited one in the last three years and 71% believe that they help the economy, only 2% believe they hurt the economy.
- 96% of voters would support their elected representative taking a strong stand to protect national parks from data centers.
- 77% of Northern Virginians support keeping local zoning laws in place to protect national parks.
- 86% of Northern Virginians support, prohibiting data centers with one mile of national parks, 57% strongly support this legislation.


#### Who Did We Talk To – A Representative Sample of 300 Northern Virginians




## Majority of Northern Virginians Have Visited a National Park in the Last Three Years

#### Northern Virginians Visiting in Past 3 Years: 66%




#### Northern Virginians Use the National Parks For Many Reasons




#### Northern Virginians Voters See Value in National Parks


#### Voters Want Representatives To Take Strong Stand To Protect National Parks




#### Strong Support for Keeping Local Zoning Laws That Protect National Parks

Recently proposals have been made to rezone land originally set aside as potential parkland around Prince William Forest and Manassas National Battlefield to instead be used to build data centers - large industrial complexes that house acres of computer systems for storing virtual information. Data centers emit loud noises and consume as much energy as 25,000 households per year and millions of gallons of water a day.

#### 9 in 10 Republicans and Democrats Support Prohibiting Data Centers Within 1 Mile of Parks


State lawmakers are considering legislation that would prohibit large industrial data centers from being built within 1-mile of national park, state park, or other historically significant site.



## Most Think the Data Center Companies Should Cover New Infrastructure Costs





There are several arguments for protecting and preserving national parks in Virginia. For each of these arguments, please tell me if you find them convincing or not convincing.


