



# Oregon Caves National Monument and Preserve



**Location:** Cave Junction, Oregon

**Expansion Legislation:** S. 354/Ron Wyden and H.R. 2489/Peter DeFazio

**Background:** The west's longest marble cave open to the public, Oregon Caves' streams that created and continue to sculpt the caves joins the River Styx in underground grottos; continuing its journey as Cave Creek, the water then travels through the "dining room" of the historic Oregon Caves Chateau, and remarkably, forms the only stream in the National Park System that flows unobstructed to the ocean.

The Oregon Caves National Monument and Preserve expansion will add 4,070 additional acres of federal land to the existing monument to better protect the larger watershed and the cave system. President William Howard Taft originally protected 480 acres of this area in 1909.
