Background: Background: Explore an unparalleled geological and recreational gem in the high elevations of northern New Mexico's Jemez Mountains. Scientists from all over the world have come to Valles Caldera National Preserve to study large eruptions and their deposits in one of the world's best examples of a resurgent caldera—a circular volcano with an uplifted center floor. Not unlike Yellowstone National Park—another noted caldera—the Valles Caldera is a land of superlatives. The beautiful streams, high mountain peaks and lush grass lands, old-growth timber, areas rich in cultural and tribal heritage, and abundant elk herds and other wildlife make its nearly 90,000 acres a wonderland of adventure, steeped in scientific values.

Valles Caldera National Preserve is already owned by the federal government, and managed by a special trust. The preserve's unmatched combination of geological wonders and superb recreational values make it worthy of inclusion in our National Park System, with interpretation by America's elite storytellers—our national park rangers.
