"As the former Superintendent of Joshua Tree National Park, I fully understand the critical importance of the California Conservation and Recreation Act (CDCRA) for protecting the unique ecology of the California desert, for enhancing the experience of adventurists, visitors and families who enjoy the desert, and for improving the recreational economy associated with the National Parks and other public lands located in the California desert. With its passage, the CDCRA will provide for conservation of lands in or adjacent to all three California desert national park units, including Death Valley, Mojave Preserve and Joshua Tree. It will designate sizable, appropriate and and high quality locations for off road vehicle activities. It will support ongoing military training occurring in the desert that is necessary to protect national security. Also, it will help to protect the scenic values of the unique and complex Mojave desert landscape that has been identified as one of the 100 most scenic places in the world. It is clear that all of these elements will resolve many longstanding land use conflicts and have a tremendous positive influence on conservation based tourism and recreation in the California desert region."

"For more than 37 years with the National Park Service, I've seen that the establishment of our desert national parks required consistent political leadership, extensive debate, and artful compromise. The CDCRA has required nothing less. Overtime, with positive leadership, it has gained widespread support from conservationists, off road vehicle enthusiasts, veterans, national park visitors, businesses and others who all would like to see desert based land use conflicts resolved. Now is the time for our elected representatives to come together and pass this legislation."
