The National Parks Conservation Association commissioned polling opinion research among West Virginia Voters to gauge their attitudes about national parks and policies that could further enhance and preserve them.

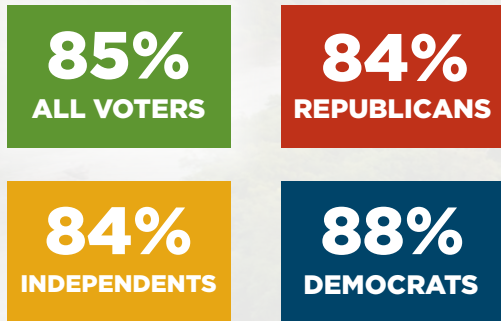

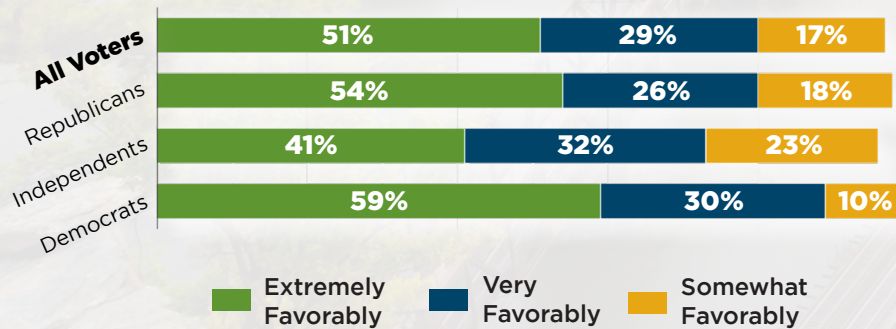
TOP BENEFITS FROM WEST VIRGINIA NATIONAL PARKS

- Preserves our rich history and heritage

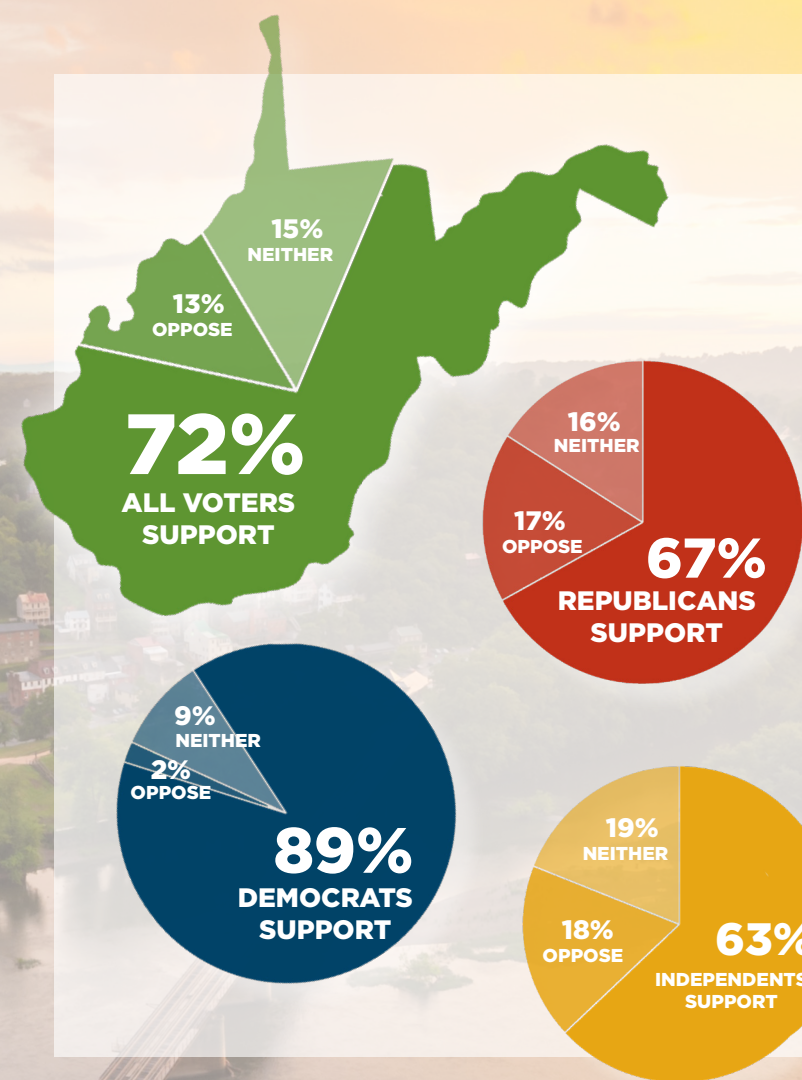
Across party lines, a strong majority of voters think West Virginia national parks are helping our economy.

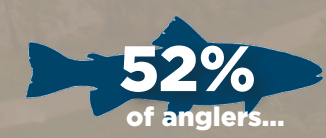
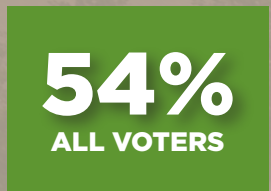
A POTENTIAL MAJOR CLIMATE AND FUNDING BILL RECEIVES STRONG SUPPORT

Congress would provide vital funding to national parks and communities across the country, including in West Virginia, for climate change. The bill would **create a historic number of new jobs** in national parks, including park rangers and scientists, as well as a Civilian Climate Corps to **employ young people and unemployed individuals** and help prepare our national parks, historic sites and public lands for any impacts from climate change and extreme weather events. It also **extends tax credits** to invest in clean energy, electric vehicles, and efficient buildings.

West Virginia voters say federal lawmakers are not doing enough to protect the water quality of lakes, rivers, and streams.

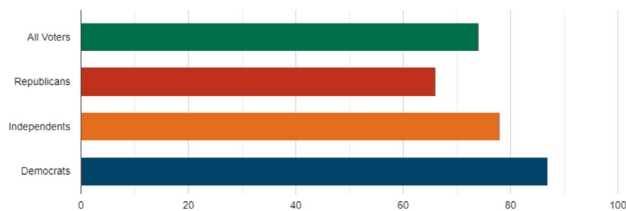

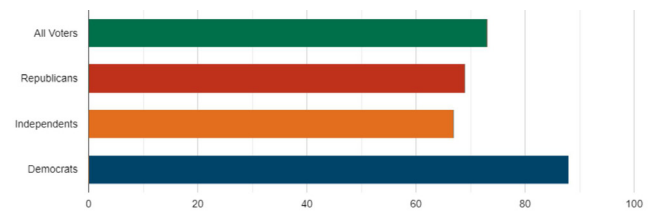

There is widespread support for Congress and federal lawmakers to prioritize conservation policies, both big and small, that address vital issues facing national parks.

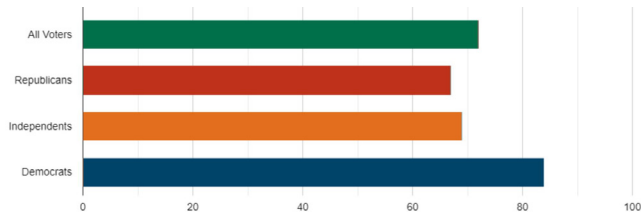
Increasing federal or state funding to extend running water and sanitation services to rural areas on septic that currently lack access.



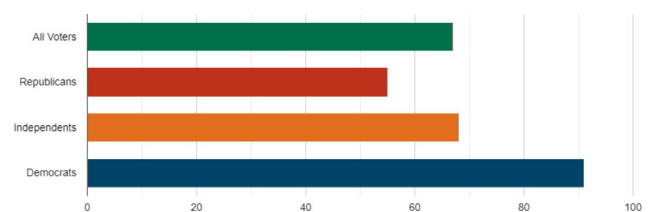
Creating new national parks and national monuments to protect historic sites and natural areas for outdoor recreation.
